Workshop Title

Mental Health Case Management: A Collaborative Approach Detailed Workshop Description

Case management is a collaborative, client-driven process for the provision of quality health and support services through the effective and efficient use of resources. Case management supports clients' achievement of safe, realistic, and reasonable goals within a complex health, social, and fiscal environment (National Case Management Network, 2009). Case management has become increasingly popular within human services; however as a profession and an area of expertise it is not widely understood. At Children's Mental Health Services (Saskatoon Health Region) seven case managers (Registered BSW's) work in 4 different program specialties (early years; generalized caseload; collaborative school model, pilot program through the justice system). In addition, one case manager is also certified in the Pet Therapy Program. We continue to advocate for broader understanding of case management within our multi-disciplinary team at Children Mental Health Services, and with a variety of systems in which we interact. The National Case Management Network (NCMN) existed from 2006 -2013 as a distinctly Canadian perspective for case management and has given us guiding documents that support case management as a profession of expertise. With funding through Health Canada in 2010 and 2012, NCMN published, Canadian Standards of Practice for Case Management and the Canadian Core Competency Profile for Case Management *Providers.* These documents will be discussed for their excellence in defining and promoting case management. Our presentation will be a multi-media Power Point presentation using case examples to help define case management within day-to-day work. Case studies will be presented to the audience for participants to identify a case plan from a case management approach utilizing the core competencies of case management.

Learning Objectives

Participants will gain a deeper knowledge/understanding of case management as an area of expertise within the field of social work.

Participants will better understand a multi-system approach to working with complex families. Participants will be introduced to a variety of roles/programs within mental health case management.

Target Audience

Everyone working within a helping profession/human service field (social workers, teachers, clinicians, physicians) whether new to this field or those who have been working for some time.

Bonnie has been a mentor in Saskatoon to other social work students at SWITCH (Student Wellness Initiative Towards Community Health) since its inception in 2005. She has recently joined the Partnership program with the Schizophrenia society of Saskatchewan in the Saskatoon Chapter.

Her most recent accomplishment involves her dog, Diesel. In 2013, she and Diesel became certified as a "Suitable Pet Therapy Team". Diesel is often seen riding in his 'mobile office' with Bonnie when she is seeing clients in their homes/communities. He is well known for his high energy and his unconditional love for everyone!

Beth's professional work and volunteer experiences have been focused in human services. Shortly after completion of a Bachelor of Education (UofS) in 1995, Beth worked with the Early Childhood Intervention Program, visiting rural families with young children experiencing developmental challenges.
