#### **Title**

1. These bylaws may be referred to as *The SASW Fee Bylaws, 2024*.

#### **Licence year**

2. The licence year is the calendar year.

#### **Initial registration and licensure**

3. The fee payable for initial registration and licensure in the Association is:

- (a) \$400 for full time practising where the application for initial registration and licensure is received prior to July 1;
- (b) \$265 for part time practising where the application for initial registration and licensure is received prior to July 1;
- (c) 60% of the amount set in clause (a) or (b) where the application for initial registration and licensure is received on or after July 1;
- (d) \$58 for student membership where the application for initial registration and licensure is received prior to September 1;
- (e) \$20 for student membership where the application is received on or after September 1;
- (f) \$125 for interjurisdictional electronic practising membership;
- (g) no fee for interjurisdictional electronic practising membership providing specialized health services.

#### **Authorized practice endorsement**

4. The application fee for an authorized practice endorsement is \$100.

#### **Licence renewal**

5. The fee payable for renewal of a licence to practise is due on or before December 1 in each year in the amount of:

- (a) \$400 for full time practising;
- (b) \$265 for part time practising;
- (c) \$125 for interjurisdictional electronic practising;
- (d) no fee for interjurisdictional electronic practising membership providing specialized health services.

#### **Late fee**

6. A member who submits their renewal application for a full time practising, part time practising or interjurisdictional electronic practising licence after December 1 but before December 31 shall pay a late fee in the amount of \$15.

**Non-practising status**

7. The fee payable for non-practising status or renewal of non-practising status is \$92.

**Removal from list**

8. (1) The registrar shall remove the name of any individual who has not renewed their licence to practise or non-practising status by December 31 from the list of members who are licensed to practise as social workers or from the non-practising list, as the case may be.

(2) A member whose name has been removed from the practising or non-practising list pursuant to subsection (1) may apply to be relicensed or reinstated as non-practising on payment of the renewal fee and an additional fee in the amount of \$50.


**Waiver of fees**

9. The registrar may, on application by a member, waive any fee where special circumstances exist.
